## **PERSONAL LETTER TO THE HONOURABLE JUSTICE RENE WILLIAMS**

**Date:** 9 June 2025

To the Honourable Justice Rene Williams,

I write this letter as a man under siege. For over a decade, I have exposed the criminal actions of powerful individuals and institutions that now retaliate against me with coordinated ferocity. These include former FBI Director Louis Freeh, fugitive financier Dani Peretz, and attorneys David Boies, Fred Heather, Gloria Allred, and Tom Girardi. My exposés, published through respected platforms including Shockya.com, SwissXTV, and TVMix, have named and documented their misconduct in connection with the Mega Group, Mossad-linked operatives, and judicial racketeering.

In 2024, I received a cease and desist letter from Freeh Sporkin & Sullivan LLP—the only such letter in over 14 years of investigative publishing. That letter was triggered by a factual article that I published through Shockya, detailing Mr. Freeh's role in coordinated legal retaliation. When I attempted to escalate this to appropriate legal channels, I was silenced. Multiple lawyers of mine have mysteriously died. Others, like Fred Heather, actively worked against my interests. I contacted FBI Special Agent Brian Gilhooly, who was the head of Special Mission to Los Angeles under Director Christopher Wray, and he received direct communication of these threats.

Your Honour, I am not merely a media entrepreneur. I am a survivor of judicial abuse, attempted psychiatric sabotage, and targeted financial terrorism. I have now turned to the courts of Antigua & Barbuda, which I believe represent the last standing beacon of true sovereign justice.

I respectfully submit the attached motion and supporting exhibits to formally expand jurisdiction, join the named parties to the RICO case, and compel testimony from Louis Freeh and other material actors. I trust in the rule of law in your Honour's courtroom.

It must be noted that I am not alone. There are **many other victims and witnesses** who share my experiences and have stepped forward, offering to provide sworn testimony in support of this motion and this case. Their voices, like mine, have been suppressed and ignored by corrupted systems abroad. I bring them with me into this courtroom, and I ask that their truth be heard through these proceedings.

## **PRO SE MOTION TO EXPAND JURISDICTION AND COMPEL TESTIMONY**

### ***I. INTRODUCTION***

This is a motion to expand jurisdiction in the above-captioned matter, and to join and compel testimony from key foreign actors whose direct conduct, communications, and

retaliatory actions against the Claimant form part of a unified racketeering enterprise. The named parties include Louis J. Freeh, David Boies, Fred Heather, Dani Peretz, Gloria Allred, and Tom Girardi.

The Claimant seeks judicial recognition of the interconnected and transnational nature of this conspiracy, and requests this Honourable Court to exercise its inherent and sovereign jurisdiction to:

1. Compel testimony and/or depositions from foreign actors;
2. Join these individuals and their firms to the current RICO action;
3. Issue protective orders preventing further intimidation, suppression, or interference.

## ***II. FACTUAL BACKGROUND***

1. In December 2024, Freeh Sporkin & Sullivan LLP, acting on behalf of former FBI Director Louis Freeh, sent the Claimant a cease and desist letter threatening legal action over investigative journalism published on Shockya.com and TVMix.
2. This is the only such legal threat received in over 14 years of exposing criminal misconduct involving the Mega Group, Mossad-linked infiltration, and organized legal abuse.
3. Claimant's former attorney, Fred Heather, was directly implicated in sabotaging legal complaints, aligning himself with Gloria Allred and Tom Girardi, and admitted he could not act due to internal firm politics linked to Louis Freeh.
4. FBI Special Agent Brian Gilhooly, then head of Special Mission to Los Angeles under Director Christopher Wray, was contacted directly by the Claimant via email on January 19, 2022, and informed of the ongoing intimidation and obstruction.
5. Claimant has documented evidence of coordinated attacks including false psychiatric 5150 attempts, targeted financial interference, and unexplained deaths of legal counsel supporting his cause.
6. Dani Peretz, named in multiple international criminal investigations, is a fugitive from Greek and Swiss authorities and currently evading Interpol notices while operating from Florida, USA.
7. All parties named in this motion are factually and legally tied to the suppression of the Claimant's lawful commercial operations, media platforms, and sovereign initiatives under SwissX and associated trusts.

8. Numerous other witnesses and victims exist who corroborate the systemic abuse outlined in this motion. Many are prepared to provide sworn affidavits and testify in open court.

### ***III. LEGAL BASIS***

1. Under principles of transnational RICO liability and common law conspiracy, foreign actors may be joined where the conduct has material impact on Antigua & Barbuda or its residents.
2. The Cease and Desist letter constitutes a legal threat which waives testimonial immunity and triggers evidentiary obligations.
3. Mutual Legal Assistance Treaties (MLATs) and Letters Rogatory may be used to compel compliance by foreign courts.
4. Protective orders are warranted where evidence of intimidation, interference, or retaliation is present.

### ***IV. RELIEF REQUESTED***

Claimant respectfully requests the following:

1. That Louis Freeh, Fred Heather, David Boies, Gloria Allred, Tom Girardi, and Dani Peretz be formally joined as Respondents in this matter.
2. That this Honourable Court recognize its authority to enforce extraterritorial RICO claims based on predicate acts affecting the Claimant and this jurisdiction.
3. That subpoenas and/or Letters Rogatory be issued to compel sworn depositions and production of evidence.
4. That protective orders be entered for the Claimant, witnesses, and whistleblowers.
