Despite the fact that the *Wall Street Journal* is owned by the **Murdoch Group (FOX TV)**—a corporate entity with ties to named defendants in this litigation—the three articles provided critical investigative exposure of **Gloria Allred's legal misconduct**. These pieces triggered formal investigations into Allred's conduct by both the **California State Bar** and the **Washington, D.C. Bar**, marking a turning point in the public record and legal accountability for her actions.

This submission presents a comprehensive, evidence-based update to the Honourable Court regarding a coordinated international conspiracy targeting the Claimant. The allegations include racketeering, political retaliation, judicial abuse, and systemic foreign interference against the sovereign interests of Antigua and Barbuda. It is offered in support of pending matters before this Court involving the abuse of foreign litigation processes,



ongoing U.S. federal investigations, and the illicit targeting of both the Claimant and the Government of Antigua.

The Claimant respectfully requests that this update be formally entered into the record and that the Court consider the ongoing criminal and civil investigations across multiple jurisdictions, including those already under review by the U.S. Southern District of New York (SDNY).

## **II. PRIMARY ALLEGATIONS**

### ***1. International Embezzlement and Insider Fraud***

- **Dani Peretz** (brother-in-law) arrested in Switzerland and Greece.
- Embezzled funds from SwissX and FilmOn.
- Collaborated with legal and financial actors to redirect assets offshore.

### ***2. Racketeering through Fabricated Litigation***

- Operated by **David Boies, Gloria Allred, Fred Heather, Louis Freeh**.
- Plaintiffs: **Marguerita Nichols, Lauren Reeves, Chasity Jones**.
- 27 pages of coordinated texts expose witness coaching and fraud.
- **\$900M judgment** (Nichols v. David) is under appeal; plaintiff's counsel under State Bar scrutiny.
- **Tom Girardi** ghostwrote the complaint.

### ***3. Alpha Nero as Legal Entrapment Vessel***

- Yacht used for offshore legal planning, beyond subpoena reach.
- Formerly tied to Russian shell corporations.
- Controlled by syndicates linked to **Boies, Bronfmanns, Shari Redstone**.

### ***4. Violation of U.S. Federal Orders via LimeWire 2.0***

- LimeWire 1.0 shutdown by SDNY injunction.
- Resurrected as LimeWire 2.0 in Austria.
- WMG/UMG contracts defy U.S. court.



- **David Boies is architect of the LimeWire conspiracy**—linked to trafficking networks through suppression of CSAM monitoring.
- **Alki David exposed LimeWire's criminal infrastructure** and was instrumental in the original SDNY case.

### ***5. Targeted Reprisal and Retaliation***

- Subjected to media attacks, legal harassment.
- Vocal **anti-vaccine advocate** and collaborator with **Robert F. Kennedy Jr.**
- Founded **CBSYOUSUCK.com** (2011) to expose CSAM distribution by CBS Interactive.
- Affirmed in part by **Judge Dale Fischer**, who ruled there was potential for **inducement of infringement**.

### ***6. Hollywood Coordination and Suppression***

- Media blacklisting coordinated by **Shari Redstone** and affiliated partners.
- Evidence documented on **cbsyousuck.com**, FilmOn, and Shockya.

4. **Protection** for Claimant and Antiguan assets against retaliatory litigation.
5. **Full inquiry** into the Alpha Nero, LimeWire 2.0, and all linked entities.

#### **Final Statement:**

The Claimant respectfully submits that this Honourable Court has both the jurisdiction and responsibility to shield this matter from foreign subversion. Aligning with the precedent and findings of the U.S. District Court (SDNY) is not merely strategic, it is essential to uphold the rule of law and defend the sovereignty of Antigua & Barbuda against transnational legal manipulation and criminal conspiracy.
