REGARDING GLOBAL CRIMINAL RECORD STATUS, UNLAWFUL DETENTION, AND JUDICIAL  
INTIMIDATION IN THE UNITED STATES

I, **Alkiviades David**, a British citizen and lawful resident of **Antigua and Barbuda**, make the following  
declaration to this Honourable Court:

I. GLOBAL CRIMINAL RECORD STATUS

1. I affirm that I have **no criminal convictions** in the **United Kingdom**, the **European Union**, the **United States**, or in any other country **except** the following disclosed and fully adjudicated matter:
  - **Jurisdiction:** St. Kitts and Nevis
  - **Offense:** Importation of industrial hemp
  - **Classification:** Misdemeanor
  - **Disposition:** No custodial sentence, no probation, no subsequent charges
  - **Context:** The hemp imported was **non-psychoactive** and part of a sustainable development and biofuel research initiative under the SwissX regenerative platform.
2. Apart from the above, I have **no felony convictions, no financial crimes, no violent offenses, and no narcotics-related charges** in any jurisdiction globally.

II. ILLEGAL DETENTION AND INTIMIDATION IN LOS ANGELES COUNTY

3. In the year **2023**, I was **unlawfully detained for six days** in **Los Angeles County Jail** (California, United States) on an alleged **contempt of court** charge stemming from a **civil proceeding**, not a criminal matter.
4. My detention occurred in conditions that were inhumane and abusive:
  - My **ADA-certified service animal, Vader**, was **illegally taken from me** despite clear documentation of my disability status.
  - I was held under constant artificial lighting, denied medical care, and surrounded by violent and unstable inmates without protective custody.
  - I was not permitted meaningful access to my legal team or necessary accommodations throughout the period of detention.
5. The purpose of this detainment appeared to be **coercion and retaliation** related to my **ongoing whistleblower efforts**, public exposure of media and legal corruption, and refusal to submit to corrupt settlement offers.

III. MOTION FOR JUDICIAL RECUSAL

6. During this ordeal, I filed a **motion for recusal** of **Judge Thomas Falls**, who presided over the contempt proceedings, based on:

- Clear **judicial bias**
  - **Failure to uphold my disability rights** under federal law
  - **Ex parte behavior** and **unlawful use of incarceration as intimidation**
  - Retaliation for my public criticisms of corruption in the California court system
7. Judge Falls was subsequently **reassigned to traffic court**, a development that lends further weight to the legitimacy of my claims.

#### IV. PURPOSE OF THIS DECLARATION

8. I submit this declaration to:
- Establish my **law-abiding character** and clarify my **global legal status**
  - Disclose and contextualize the **single misdemeanor** on my record
  - Document **abuse of legal authority** and **human rights violations** committed against me by the Los Angeles Superior Court
  - Assist this Honourable Court in evaluating any prejudicial or misleading claims made against my name in foreign jurisdictions
9. I remain available to testify, provide documentation, or submit further affidavits as this Court may require.
