1. Introduction and Purpose

I, Alkiviades David, of SwissX Island, Antigua and Barbuda, make this affidavit and notice bundle for the purpose of preserving the evidential record, notifying the Judicial Committee of the Privy Council and the Criminal Investigations Department of Antigua and Barbuda of the present status of the record, and formally consolidating the materials on which I rely.

This document is intended to be read as a formal, court-safe consolidation of the matters already placed on record by me. It is not intended to replace any previously filed affidavit, notice, complaint, or witness statement. Rather, it is intended to bring those materials together in an orderly and readable form, and to preserve the procedural chronology.

2. Principal Filed Materials

I confirm that the following principal document is already filed on the relevant system and is relied upon by me:

I further rely upon the affidavit and witness materials of Shiley D. Hinton, together with the contemporaneous supporting material referred to in that record. To the extent that Shiley D. Hinton's affidavit is separately filed, separately served, or separately annexed, I ask that it be read together with the principal affidavit and treated as part of the same evidential body.

I stand by those materials.

3. CID Registration and Formalisation

I confirm that the same evidential body is being separately presented to the Criminal Investigations Department in Antigua and Barbuda for registration, affirmation, notarisation, preservation, and any resulting signed, stamped, endorsed, or otherwise authenticated copy or artifacts thereof.

I ask that CID formally log the material, assign an appropriate reference, and preserve any certified copy, signature page, stamp, or receipt generated through that process.

4. Record of Notice and Limited Response

CID Antigua has already received repeated written notice from me by email, including multiple communications sent on 14 April 2026, 15 April 2026, and 17 April 2026. The Attorney General's Chambers and related public authorities have likewise been repeatedly notified.

On my case, the response to date has been limited and has not substantively engaged with the full body of material I have placed on record. I advance that point not as a merits finding, but as part of the procedural and evidential history requiring preservation and scrutiny.

5. Serious Criminal Complaints Already Made

I record that I have already made serious criminal complaints supported by documentary materials, including:

- A complaint concerning, on my case, interference with the court record, including alleged falsification or alteration of filed material connected to proceedings in Antigua and Barbuda; and

- A complaint supported by contemporaneous communications and evidence relating to the death of Asot Michael, which I have placed before the relevant authorities for preservation and investigation.

I have also completed and signed a handwritten witness statement on official Royal Police Force of Antigua and Barbuda witness statement forms. A typed transcription of that statement is included below, together with exhibit images of the handwritten pages.

6. Multi-Jurisdictional Record

These matters are not confined to a single jurisdiction. The evidential record has been placed, in whole or in part, before proceedings and authorities in the United Kingdom, the United States, Switzerland, Greece, human rights fora, and the Supreme Court of the Eastern Caribbean.

I rely on this not as amplification, but to demonstrate that the matters I raise have been consistently pursued through lawful channels across multiple jurisdictions and are fully documented on the record.

7. Related Procedural Context

I further rely, as contextual procedural background, on the recusal of Justice Rene Williams in the related Brian Stuart-Young / Global Bank matter in the same court, in respect of which I filed an amicus. I also note that Prime Minister Gaston Browne has publicly expressed concern regarding that recusal and the surrounding circumstances.

I advance that context only as procedural background relevant to preservation of the record and proper scrutiny.

8. Disability, Safeguarding, and Treatment Concerns

I am a disabled person. On my case, prior attempts by me to complain or seek assistance have at times been met with detention, arrest, wrongful incarceration, physical confrontation, or conduct that I experienced as mocking, taunting, or dismissive of my disability.

I further record, fairly and with care, that although Corporal Hughes is the only officer from whom I have received any response, I remain concerned that the response history as a whole reflects deficiencies in disability-aware handling, medical-context awareness, and the timely evaluation and escalation of serious information presented in real time.

I rely on these matters as safeguarding concerns and as part of the procedural background in which I have been attempting to pursue my complaints.

9. Typed Transcription of Handwritten Witness Statement

The following is a typed transcription prepared from my handwritten statement on Royal Police Force of Antigua and Barbuda witness statement forms. It is intended to supplement, not replace, the original handwritten pages exhibited at Schedule A.

I, Alkiviades Andrew David, make this statement from matters within my own knowledge and belief.

This is a continuation statement relating to the matters concerning the death of Asot Michael and associated evidence, including contemporaneous communications between Asot Michael, myself, and various legal and financial actors across British and American jurisdictions.

There is a clear pattern of evidence linking the surrounding circumstances of Asot Michael's death to financial and legal disputes involving high-value sovereign-linked assets of Antigua and Barbuda, including assets connected to the Harmonia Trust.

Within the Harmonia Trust are several high-value assets, including intellectual property, technology assets, and media-related assets such as the ECIG patent system and the FilmOn library. These assets have been the subject of attempted appropriation and litigation over many years.

In my capacity as a digital media entrepreneur, I have been involved in multiple legal disputes over the past fifteen years, including but not limited to FilmOn (FOTV) vs DoubleVerify, Alkiviades David vs CBS, matters relating to the Michael Jackson Estate, and Alkiviades David vs Fox Networks.

Through this work, I have uncovered patterns of financial and legal conduct that I believe demonstrate the commingling of assets and the improper handling of media, intellectual property, and financial interests.

Further, I have publicly exposed evidence relating to file-sharing systems, including LimeWire-related distribution structures, and the monetization of digital content through networks tied to CBS Interactive and related entities.

Evidence has been placed on record, including at CBSYousuck.com, where a large number of files and supporting materials are catalogued.

There are references to tens of thousands of illicit files being distributed through systems connected to Media Defender, a company owned by entities linked, on my case, to NXIVM-related financial networks and the Bronfman family.

I have reason to believe that these systems and financial flows intersect with broader criminal activity, including exploitation and trafficking networks.

I identify a range of individuals and entities involved in financial and legal activities connected to these matters, including Dani Peretz, Christos Leventis, Sara Bronfman, Clare Bronfman, David Boies, Martin Delaney of Boies Schiller, Howard Kennedy, and Charles Russell. I state that these individuals and entities are connected, in my understanding, through financial arrangements, legal representation, and coordinated litigation activity.

In relation to Antigua and Barbuda, there are significant developments including the Alpha Nero matter, where I was an appellant alongside Prime Minister Gaston Browne and others, including Brian Stuart-Young. This case has been described publicly by the Government as involving lawfare affecting the sovereignty of Antigua and Barbuda.

I state that I was in contact with Asot Michael in the days leading up to his death. There were ongoing discussions involving legal and financial matters, including disputes and negotiations relating to assets and legal positioning. I believe that the circumstances surrounding his death require full investigation.

I further state that evidence has emerged linking certain individuals and financial networks to NXIVM, including the Bronfman family. I state that NXIVM has been publicly associated with serious criminal conduct, including exploitation and trafficking offenses. I believe that individuals connected to these networks have intersected with matters in Antigua and Barbuda, including through financial structures, legal actions, and business dealings.

I have been subject to sustained legal and financial pressure, including actions involving members of my own family and associated parties. I have also experienced threats, intimidation, and interference with my ability to conduct business and protect my family, including my minor children.

When attempting to report these matters to authorities, I have experienced detention, arrest, coercive treatment, physical confrontation despite my disability, and conduct I perceived as mocking or dismissive of my disability. I believe this reflects serious deficiencies in handling and safeguarding.

This is not a case of misunderstanding. This is a matter that has developed over a prolonged period, involving multiple jurisdictions, multiple legal proceedings, and a large body of evidence. There are multiple witnesses and victims, and I believe that these matters require urgent and serious investigation. I stand by this statement.

10. Relief and Requests

I respectfully request that:

- This affidavit and notice bundle be placed on the record;
- The principal affidavit and the affidavit / witness materials of Shiley D. Hinton be read together;
- CID formally register and preserve the materials provided;
- Any signed, stamped, endorsed, notarised, registered, or otherwise authenticated CID copy, or artifacts thereof, be preserved as part of the official record;
- Further engagement with me be conducted with appropriate disability-aware, medically informed, professional, and non-intimidatory handling.


11. Statement of Truth and Execution

I am married man living at the above address. Me and my wife Shirley D Hinton has been living here a little over a year without leaving prior to her arriving. I have been here living in and off in Antigua for three years. I did that in Malibu California I represented myself as acting counsel to counsel for the Gustav Baine Government. In my capacity as a litigant in person, at the Antigua Caribbean Supreme Court with summons to the Court against Attorney General Steadroy Benjamin appointed by Justice Renae Williams as Amicus on my Court Case no. A.NU.H.CV.2015-1 of 149. It is in default and to have supplied evidence that the claim form was tampered with by the Attorney General's office. To have filed with the court a notice of clarification as to why the claim form was altered which by doing so affected the jurisdiction of the case. It is clear that the original claim number was tampered with from fourteen names in the defendants list to thirteen. To have filed

 Public notice concerning this malfeasance to the murder of Asot Michael in multiple pillars of evidence. One is contemporaneous emails between Asot Michael, myself and a team of British and American lawyers. On my case at the Privy Council in London I have revealed a Prooble net-work that includes the mingling of financial assets such as Drop Box subscription revenue or by example the sale of lime wire NFT a furtherance to the industrial scale distribution of the evidence on file at the C.I.D in Antigua and Barbuda as well as my public repository at CBSHousuck.com data. Sixty seven thousand two hundred child porn video files are documented, categorized and given search triggers by the company Media Defender a company owned by Next VM mainly Claire Sara and Belgar Bron from of CBS and Kara mount / Universal Music Group ownership.
