1. EXECUTIVE STATEMENT

This document constitutes a formal criminal complaint and a comprehensive evidentiary dossier.

It is submitted to the Criminal Investigations Department of Antigua and Barbuda for immediate action, specifically:

Immediate criminal investigation

Urgent preservation of all relevant evidence

Identification and interviewing of responsible parties

Potential escalation to international law enforcement mechanisms, including INTERPOL

The complaint arises primarily from events connected to:

High Court Claim No. ANUHCV2025/0149 (Antigua and Barbuda)

Related proceedings in the United Kingdom

Related proceedings in California, United States

Core Position

The complainant submits that there exists a coherent and documented pattern of conduct across multiple jurisdictions involving legal actors, media-linked entities, and associated individuals that may amount to:

Obstruction of justice

Evidence tampering

Abuse of process

Coercive legal strategy

Misuse of psychiatric frameworks

This dossier does not invite the CID to accept any conclusions.

It presents sufficient prima facie evidence and meticulously structured material to justify a full criminal investigation without delay.

2. CURRENT LEGAL POSITION ACROSS JURISDICTIONS

United States (California)

The Jane Doe litigation has progressed through trial under procedurally contested circumstances, including:

pre-trial objections on notice and fairness grounds,
Requests for Admission deemed admitted without proper service, and
irregularities relating to representation.

A significant jury verdict was entered (subsequently reduced), and the matter is now in the appellate phase.

Critical development:

The Respondent has failed to file the required appellate brief, placing them in default posture under Rule 8.220.

United Kingdom

Enforcement-related proceedings connected to the same underlying matters are currently subject to pause /
adjournment considerations.

Conduct involving Howard Kennedy LLP and associated individuals has been formally raised, including:

courtroom incident (25 July, Courtroom 8),
and broader professional conduct concerns.

Antigua & Barbuda

Proceedings are ongoing in the High Court, with:

multiple defaults recorded, and
issues raised concerning the handling of filings within the Attorney General's Chambers.

A criminal complaint has now been submitted to CID, and the matter has moved into an investigative phase.

3.1 Evidence Tampering

Potential alteration, substitution, or suppression of:
court filings
party lists
procedural records

3.2 Obstruction of Justice

Conduct that:
delayed proceedings
diverted responsibility
prevented recognition of defaults

3.3 Conspiracy to Pervert the Course of Justice

Where multiple actors across jurisdictions may have:
coordinated legal positioning
restricted evidence flow
influenced procedural outcomes.

3.4 Abuse of Legal Process

Including:
repetitive litigation pressure
reputational leverage
selective evidentiary use
cross-border enforcement tactics.

3.5 Misuse of Psychiatric Mechanisms

Evidence suggests possible use of:

psychiatric reports
capacity framing
disability narratives

3.6 Cross-Border Coordination

Overlaps between Antigua proceedings, UK legal actions, and US litigation strongly suggest possible transnational coordination.
