**NOTICE TO COURT — INTEGRATION OF EXHIBITS MS, KC, DJ  
(a/k/a JD1) & JD1**

**1 - Purpose of Notice**

The Claimant hereby places before this Honourable Court a consolidated record of four sworn witness declarations which, when read together, constitute a single continuum of evidence spanning 2004 – 2019 and demonstrating a coordinated pattern of sexual coercion, filming, and subsequent retaliation within the Viacom / Paramount corporate structure.

1. Exhibit MS – Mercedes Stanley Declaration (2019)
2. Exhibit KC – Keenan Carter Declaration (2018)
3. Exhibit DJ – Daniel Jackson Declaration (2019)
4. Exhibit JD1 – John Doe’s Assaults 2 (2005 & 2016)

It is now confirmed and declared for the record that Mr. Daniel Jackson is the individual identified as “John Doe” in Exhibit JD1. His identity verification unifies the anonymised statement (JD1) with his executed declaration (DJ), thereby authenticating both as one continuous sworn testimony.

**2 - Chronological Alignment of Facts**

2005 – MTV Santa Monica: First assault of minor Daniel Jackson by Brian Graden in MTV restroom during audition for “Next.” Establishes initial predicate act of child sexual abuse under colour of employment.

2006 – MTV Auditions: Carrington auditions for “Parental Control/Next”; meets Graden. Links Carrington to same predator and venue.

2010–2011 – Paramount Lot & Hilton Incidents: Reno Logan and Sumner Redstone solicit and assault Carrington; Brad Grey and Weinstein participate. Shows corporate knowledge and executive ratification.

2014–2016 – Graden Residence Abuse & CSAM Creation: Unprotected sex parties filmed by Ted Sun; Larry Stein participates. Constitutes ongoing production of child-sexual-abuse material.

2016 – Dual Rapes of Carrington and Jackson: Both drugged and filmed by Graden and Stein on camera. Connects John Doe (now identified as Jackson) to Carrington within same event.

2017 – Variety Confirmation: Journalist Debra Birnbaum confirms multiple witness accounts. Creates independent press record of notice and industry knowledge.

2019 – Ongoing Threats: Graden and Viacom attorneys threaten Carrington to withdraw criminal reports. Evidence of continuing enterprise and obstruction of justice.

### **3 • Evidentiary Synthesis**

1. Identity Authentication: Daniel Jackson’s dual statements (DJ & JD1) resolve anonymity and convert John Doe’s narrative into fully sworn, identifiable evidence.
2. Corporate Complicity: Repeated references to Reno Logan and Shari Redstone prove actual knowledge within Paramount executive hierarchy.
3. Continuity of Enterprise: The abuse sequence (2005-2019) meets standards of pattern and continuity under RICO-analogous frameworks and ECSC Rule 29.4.
4. Forensic Obligation: Video evidence described in KC, DJ, and JD1 requires chain-of-custody preservation and international MLA transmission to Interpol for analysis.
5. Independent Corroboration: Three separate witnesses (MS, KC, DJ) plus the self-corroborated JD1 account demonstrate consistency without collusion and fulfil probative corroboration requirements.

### **4 • Prayer for Judicial Acknowledgment**

The Claimant respectfully requests that this Honourable Court please:

1. Receive and seal this Notice and its referenced Exhibits MS, KC, DJ, and JD1 as a single record entitled the Carrington Corroboration Bundle (2004-2019);
2. Recognize Daniel Jackson as the verified identity of John Doe in Exhibit JD1 for purposes of authenticity and continuity of evidence;
3. Acknowledge the four declarations as mutually reinforcing proof of systematic sexual

abuse, blackmail, and enterprise-level racketeering under Viacom / Paramount supervision;  
4. Transmit the record to the Attorney General and the Commissioner of Police for Antigua & Barbuda for appropriate criminal referral and Mutual Legal Assistance action.
