**NOTICE OF CONTEMPT  
ACTUAL AND CONSTRUCTIVE NOTICE  
AND APPLICATION FOR DIRECTIONS**

The Claimant files this Notice to bring to the Court's attention the Defendants' persistent failure to acknowledge proceedings properly served and repeatedly publicised. The Defendants—thirteen (13) of fourteen—are senior UPP officers resident in Antigua and Barbuda. Their identities, roles, and residency are unchallenged on the record.

**Evidence of Actual Notice**

3. The Claimant personally informed Mr. Harold Lovell (former UPP Leader, practising attorney) of the claim, its filing date, and the UPP Defendants' involvement—on at least three separate occasions. Mr. Lovell acknowledged receipt and expressed no dispute.

No defence, acknowledgment, or appearance has been filed despite this direct oral notice from a senior party officer with direct knowledge of the Defendants and proceedings.

**Evidence of Constructive Notice**

5. The proceedings have been broadcast on three Antiguan national radio stations (names and dates on record) identifying the Court, claim number, Claimant, and UPP Defendants.

Shockya.com has published uninterrupted coverage for over three years—naming Defendants, quoting pleadings, and linking to the Court file.

On 12 May 2025, island.swissx.com published a detailed article mirroring the Claim Form, including the Court name, claim number, parties, and jurisdiction. That article remains live, accessible, and unretracted.

All Defendants reside within the Court's territorial reach; none has denied knowledge or challenged service.

**Prima Facie Contempt**

9. This conduct—knowing non-compliance by parties under the Court's jurisdiction—amounts to wilful disobedience and interference with justice.

**Relief Sought**

10. The Claimant therefore respectfully applies for:

- a. An order requiring the UPP Defendants to show cause, within seven (7) days, why they should not be cited for contempt;
- b. Costs of this application;
- c. Such further directions as the Court deems fit to secure compliance.

Filed in good faith. This Notice is not political; it is procedural. The Court's authority must not be ignored.
